



# TBF OF PA — DISTRICT SEVEN LAKE ONEIDA, NY 2009 OPEN BASS TOURNAMENT

**Date:** Saturday, August 29, 2009

**Location:** Lake Oneida, NY (Oneida Shores Ramp)

**Gate Opening:** 6:00am (parking fees are to be paid prior to entering the facilities)  
**Registration:** 6:15am to 6:50am (look for boat in parking with an American Flag on Stern Light)  
**Launch Time:** 6:50am to 7:00am  
**Weigh-in Time:** 3:00pm (scale will be set up between the path leading from parking lot to ramp)



**ENTRY FEE: \$80 per team**

**Optional Lunker Fee \$10 per team**

*1st Place 35% of entry fees*

*2nd Place 25% of entry fees*

*3rd Place 15% of entry fees*

*100% Lunker Payout*

### Tournament Rules

- 1) Pre-registration will be allowed (payment by check only)
- 2) Registration will be allowed at ramp during check-in (cash only)
- 3) All NY Fishing and Boating rules & laws apply
- 4) A valid NY fishing license is required
- 5) Limit of five (5) fish per team (teams DO NOT have to be a TBF member)
- 6) Minimum length will be 12"
- 7) Fish will be measured closed mouth & tail pinched or fanned
- 8) Artificial lures, pork trailers and Gulp will be allowed (NO live bait allowed)
- 9) All boats must be back at the ramp by 3:00pm. If a team is late, they will be assessed a penalty of 1lbs. Per minute up to 15 minutes. After 15 minutes the team will be disqualification
- 10) A team is limited to two (2) anglers per boat and fishing MUST be done from the boat
- 11) There will be NO culling of dead fish
- 12) A dead fish can be weighed, however, will incur an 8oz. Or .50 pound penalty deduction for each dead fish weighed. A total of three (3) dead fish will equal a disqualification
- 13) A dead fish cannot be weighed in for lunker
- 14) In the event of a tie, it will be broken by the team's lunker (must be alive)
- 15) The Tournament Director's ruling is final
